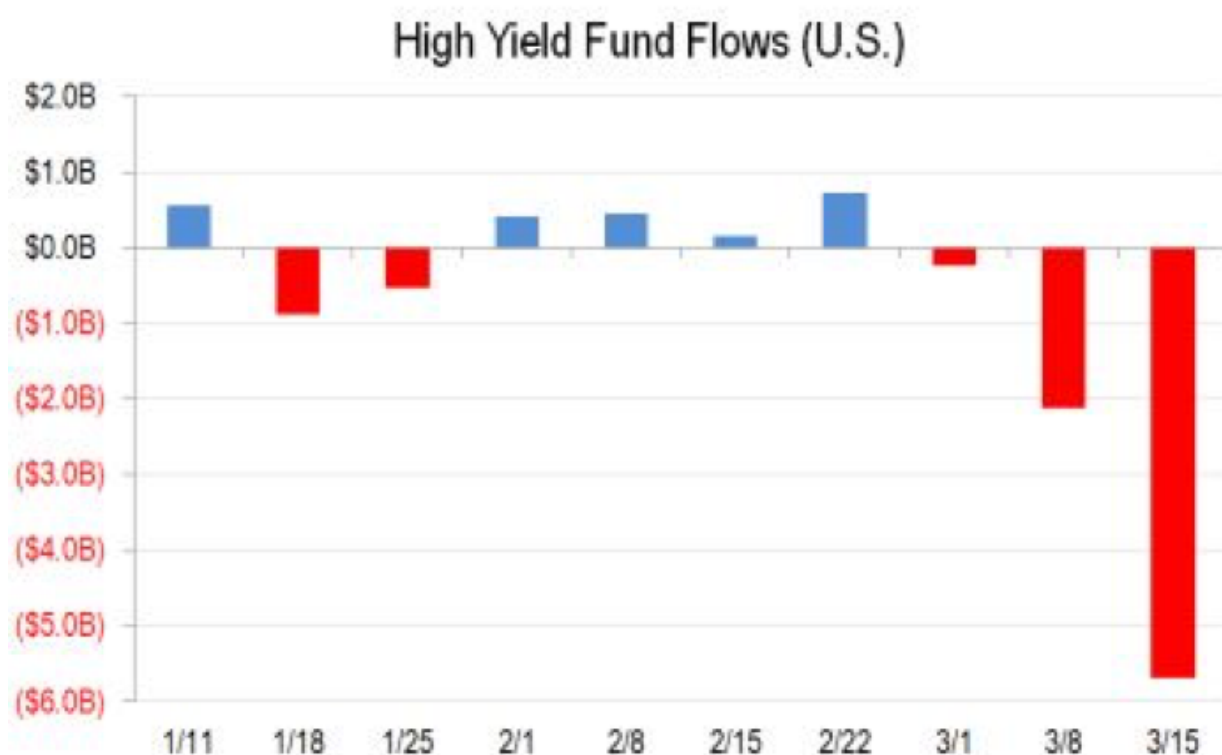


Springing a Leak
