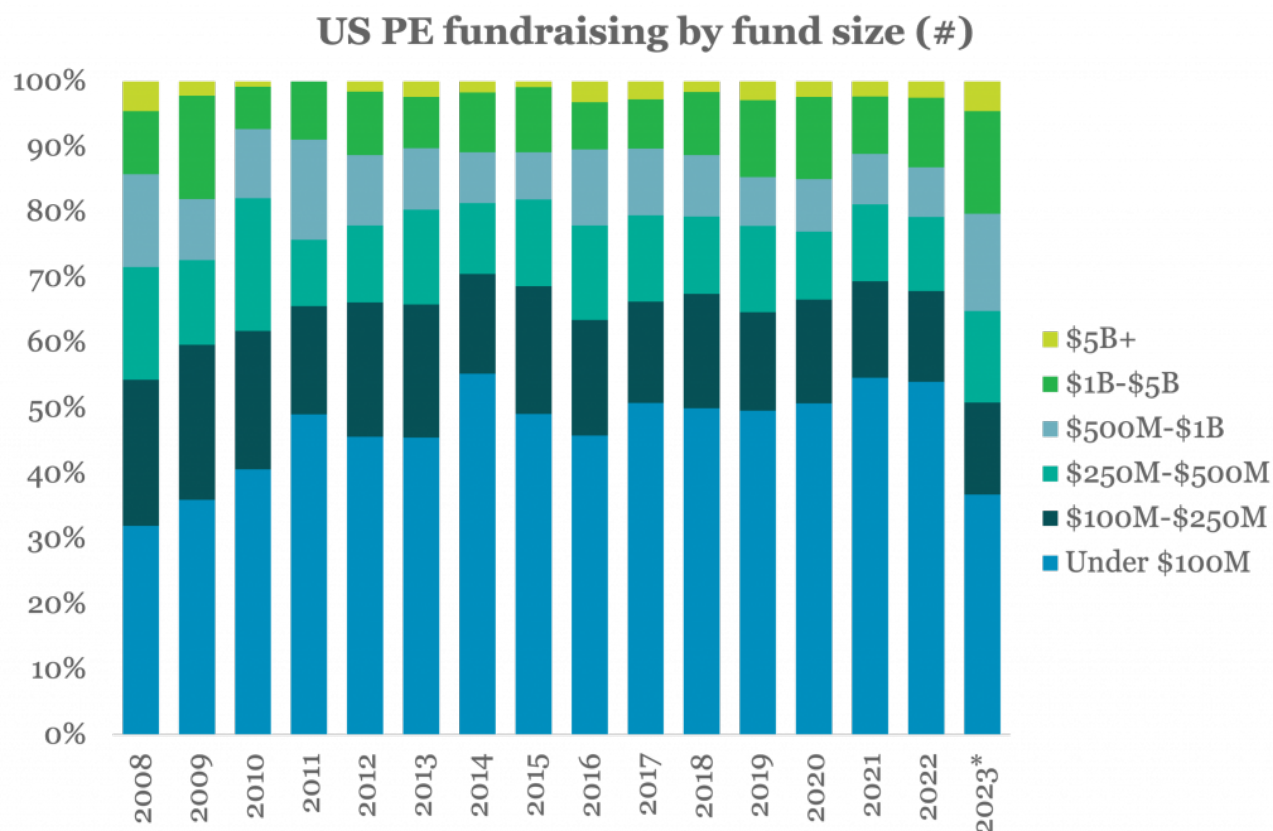


Mega-deals down, mega-fundraising rising

Currents are crashing into each other at the biggest ranges of the PE market. A couple weeks ago we covered a sizable drop in mega-deals, first unearthed in [PitchBook's Q3 US PE Breakdown](#). But the same study also found a sizable increase in mega-fundraising. Through Q3, funds of \$1 billion or more are accounting for over 20% of fundraising by fund count. That's the biggest share for \$1B+ funds since 2009, and it's actually bigger than it was that year (18%). We haven't seen a 20% share for \$1B+ funds since the GFC, but we are now—in a landscape that's getting redefined around higher interest rates, smaller deal sizes and equity contributions breaching 50% for the first time.

So, the data is suggesting that LPs are backing big funds at a historically fast clip, while the big funds themselves are migrating down market into middle-market deals. The report also notes that some of the biggest funds are taking more time to close, and are settling for smaller targets than they originally wanted.
